The new registrations* of cars increased by 66.0% in Q II 2017, compared to Q II 2016

- The new registrations of road vehicles for passenger transport increased by 64.1 % in Quarter II 2017, compared to Quarter II 2016.
- In Quarter II 2017, the new registrations of vehicles for goods transport increased by 8.7% compared to Q II of the previous year.

In Q II 2017, compared to the same quarter of 2016, **the new registrations of road vehicles for passenger transport** registered rises for the categories *passenger cars* and *mopeds and motorcycles* by 66.0%, respectively by 17.4%. The category *buses and minibuses* dropped by 10.2%

In the same period, **the new registrations of road vehicles for goods transport** increased by 25.1% for *lorries* and dropped for *road tractors* and *trailers and semitrailers*, by 20.6%, respectively by 5.4%.

Compared to Q I 2017, in Q II 2017 the new registrations of road vehicles for passenger transport decreased by 0.5%, while the new registrations of road vehicles for goods transport increased by 7.1%.

The evolution of the new registrations of road vehicles



Additional Information:

* New registrations of road vehicles refer to road vehicles registered for the first time in Romania. These comprise new vehicles, including those purchased under leasing conditions, as well as imported second hand cars. Re-registrations due to change of owners as consequence of cars sale, trams and trolleybuses, military vehicles, agricultural trailers and housing vehicles are not included.
