The new registrations of road vehicles, in the second quarter of 2021, and vehicles registered, at the end of the second quarter of 2021*)

- In the second quarter of 2021, the **new registrations of road vehicles for passenger transport** increased by 32.8% compared to the second quarter of 2020.
- During the same period, the **new registrations of road vehicles for goods transport** rose by 37.7% compared to the second quarter of the previous year.
- In the second quarter of 2021, the share of the new registrations of imported used passenger cars in the total new registrations of passenger cars was 78.5%.

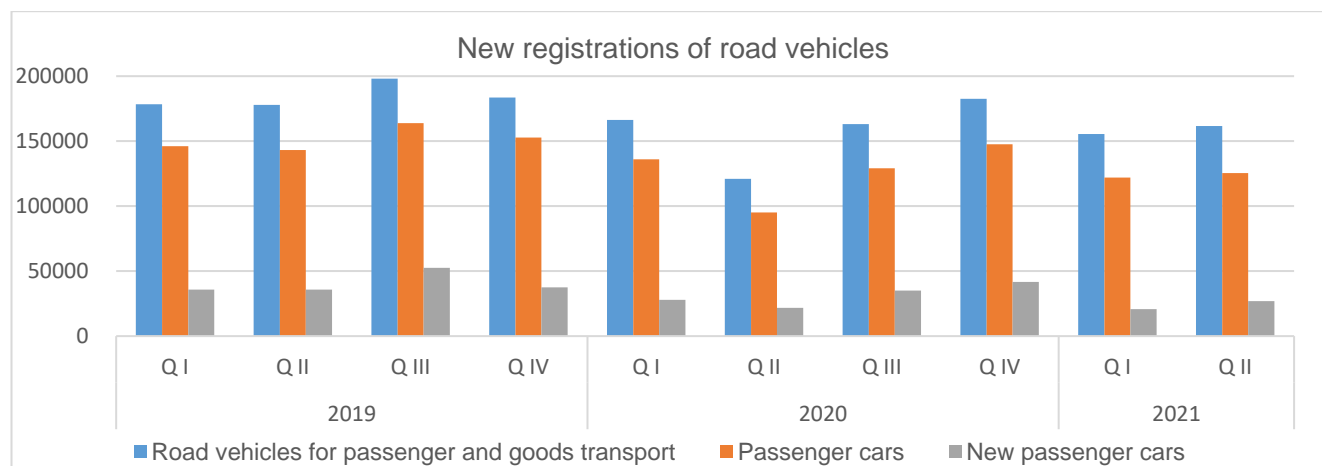

In the second quarter of 2021, the **new registrations of road vehicles for passenger transport** increased for all categories, namely: *buses and minibuses* (up 2.2 times), *mopeds and motorcycles* (+49.0%) and *passenger cars* (+32.1%). With regard to the **new registrations of new road vehicles for passenger transport**, rises were reported for all categories: *buses and minibuses* (+88.9%), *mopeds and motorcycles* (+74.8%) and *passenger cars* (+24.5%).

*) The data on new registrations of road vehicles refer to the road vehicles registered for the first time in Romania. The data on vehicles registered refer to the road vehicles classified according to the European vehicle emissions standards.

As regards the **new registrations of road vehicles for goods transport**, rises were recorded for all categories: for *road tractors* (up 2.1 times), for *trailers and semitrailers* (+52.6%) and for *lorries (special purpose road vehicles included)* (+20.3%). The **new registrations of new road vehicles for goods transport** increased for all categories, namely: *road tractors* (up 2.9 times), *trailers and semitrailers* (+84.9%) and *lorries (special purpose road vehicles included)* (+44.6%).

In the second quarter of 2021, the new registrations of road vehicles for passenger transport rose by 4.4% compared to the first quarter of 2021 and the new registrations of road vehicles for goods transport increased by 2.2%.

- At the end of the second quarter of 2021, 56.2% of the **road vehicles registered** classified according to the European emissions standards were Euro 4, Euro 5 or Euro 6 vehicles and 12.3% were Non-Euro vehicles.

Within the *passenger cars* category, the highest share was that of Euro 4 vehicles, namely 35.3%; within the *buses and minibuses* category, the greatest number of vehicles (namely 25.8%) were Euro 3 vehicles; as regards the *mopeds and motorcycles*, the greatest number of vehicles within this category (namely 30.6%) were classified as Non-Euro.

The Euro 3 vehicles prevailed within the *lorries* category (30.5%), the Euro 6 vehicles prevailed within the *road tractors* category (32.3%), and the greatest number of vehicles within the category of *special purpose road vehicles* (namely 26.7%) were classified as Non-Euro.

Additional information:

The new registrations of road vehicles comprise the registrations of new vehicles, including those of lease-purchased vehicles, as well as the registrations of imported used vehicles, classified according to the Community vehicle categories.

The re-registrations due to change of owner as a consequence of the sale of the motor vehicle are not included. Trams and trolleybuses, military vehicles, agricultural trailers and housing vehicles are also not included.

The vehicles registered, at the end of the reference quarter, present provisional data on the registered road vehicles classified according to the European vehicle emissions standards. Three- and four-wheeled motorcycles are included under the “mopeds and motorcycles” category. The special purpose road vehicles include fire brigade vehicles, mobile cranes etc.

The data do not include the road vehicles to which the European vehicle emissions standards are not applicable, namely tractors, trailers and semitrailers.
