# **Environmental protection expenditure in 2018**

- In 2018, the environmental protection expenditure at national level amounted to RON 14.7 billion<sup>1</sup>, accounting for about 1.6% of GDP<sup>2</sup>
- At national level, the highest environmental protection expenditure was recorded in waste sector, for the specialized producers, with a share of 77.5% in total waste related expenditure.
- At national level, the highest investments for environmental protection were recorded for waste water management by general government, with a share of 78.0% in total investments in waste water management.

At national level, the weight of unspecialized producers investments was 47.4% of total investments for environmental protection, followed by the investments of general government (41.1%) and by those of specialized producers (11.5%). 31.6% of the unspecialized producers' expenditure for environmental protection was in the field of "electric and thermal energy, gas and hot water production and supply", while 22.6% was for "mining and quarrying" and the expenditure for "manufacturing" accounted for 19.7%.

By environmental fields, the highest expenditure was recorded for waste management (44.1% of total expenditure for environmental protection at national level), followed by the expenditure for other environmental fields (18.7%) and the expenditure for waste water management and the air protection (16.3% each).
