### **Environmental protection expenditure in 2020**

- In 2020, the environmental protection expenditure at national level amounted to RON 15.7 billion¹, accounting for about 1.5% of GDP²
- At national level, the highest environmental protection expenditure was recorded in waste sector, for the specialized producers, with a share of 71.6% in total waste related expenditure.
- At national level, the highest investments for environmental protection were recorded for waste water management by general government, with a share of 79.7% in total investments in waste water management.



At national level, the investments of general government had the biggest share in total investments for environment protection (54.5%), followed by unspecialized producers investments (31.0%) and by those of specialized producers (14.5%). The unspecialized producers registered the biggest expenditure for environmental protection in the field of "electric and thermal energy, gas and hot water production and supply" (33.8%), the expenditure for "manufacturing industry" (19.7%) and in the field of "water intake, treatment and distribution" (19.2%).


# The structure of investments for environmental protection in environmental domains in 2020

By environmental areas, the highest expenditure was registered for waste management (39.0% of the total expenditures for environmental protection at national level), followed by expenditures for wastewater management (21.1%) and expenditures for protection of ambient air and climate (20.5%).
