# **Environmental protection expenditure in 2022**

- In 2022, the environmental protection expenditure at national level amounted to RON 20.4 billion<sup>1</sup>, accounting for about 1.4% of GDP<sup>2</sup>.
- At national level, the highest environmental protection expenditure was recorded in waste sector, for the specialized producers, with a share of 78.3% in total waste related expenditure.
- At national level, the highest investments for environmental protection were recorded for waste water management by general government, with a share of 60.6% in total investments in waste water management.

In 2022, at the national level, investments for environmental protection represented 23.6% of the total expenses for environmental protection.


At national level, the investments of general government had the biggest share in total investments for environmental protection (40.3%), followed by unspecialized producers' investments (33.9%) and by those of specialized producers (25.8%). The unspecialized producers registered the biggest expenditure for environmental protection in the field of "electric and thermal energy, gas and hot water production and supply" (33.9%), the expenditure for "mining industry" (21.3%) and in the field of "water intake, treatment and distribution" (17.2%).



In 2022, the largest investments for environmental protection were registered in the field of waste water management, with a value of 2.303.689 thousand lei current prices.





In 2022, the highest expenses for environmental protection were recorded by the "waste management" field, with a value of 10.468.171 thousand lei current prices, followed by the "wastewater management" field, with 3.635.278 thousand lei current prices.

The highest expenses for environmental protection were registered among producers specialized in the field of "waste management" with 95.0% of the expenses of this category of producers, representing 78.3% of the expenses for environmental protection at the national level for this environmental field. These are followed by the expenses of non-specialized producers for the "wastewater management" field with 39.9% of the expenses of this category of producers, representing 56.3% of the expenses for environmental protection at the national level for this environmental field.
